

Official Rules of Open-E's Sweepstakes

Sponsored by Open-E GmbH. ("*Sponsor*").

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR WIN.

1. **Survey Sweepstakes Period:** The Sweepstakes Survey begins on February 21, 2013 at and ends on March 3, 2013 at 11:59:59 PM Central European Time ("CET") (the "*Survey Sweepstakes Period*").

2. **Eligibility:** Open-E's Survey Sweepstakes (the "*Sweepstakes*") is open worldwide to individuals age eighteen (18) or older as of the date of entry, who have an active e-mail account and Internet access during the Sweepstakes Period. **VOID WHERE PROHIBITED. Subject to all applicable federal, state and local laws.**

3. **To Enter:** You may enter the Survey Sweepstakes in one way:

Only one entry per person, per e-mail address is permitted. Entrants submitting multiple entries or violating any of these Official Rules may be disqualified. No mechanically reproduced mail-in entries are allowed and any use of robotic, automatic, programmed or the like entry methods will void all such entries.

4. **Prize Drawing:** All Survey Sweepstakes entries meeting the requirements of these Official Rules will be entered into the prize drawing, to be held the day following the Sweepstakes Period – March 4, 2013. The drawing will be conducted either by independent persons or a computer program that randomly chooses the winner, from all eligible entries received and the random selection is final and binding.
